Candidates may, at the time of nominating, not later than 5:00pm (AEST) on Monday, 10 May submit to the Returning Officer, a typewritten statement which shall not exceed 200 words and a list of offices and /or positions currently and/or previously held in the Union or in any union which is amalgamated into the Union or in a State Registered Union which is associated with the Union and a passport size photograph of the candidate. Candidate statements will only be accepted online.
